



## **JUNIOR PARADE INTERNATIONAL**

**24 – 26 FEBRUARY 2022**

Junior Parade International is a non-competitive choreographic show which is open to schools. Each school can participate with a group choreography – minimum 3 elements – of a maximum duration of 4 minutes featuring dancers aged under 14 who can perform any genre and style of dance. The 17th edition will be held at Danzainfiera on 24, 25 and 26 February 2023, between 11.00/12.00 a.m. c/o the Theater – Cavaniglia Pavilion in the Fortezza da Basso, Florence.

### **HOW TO GET THERE**

On the [www.danzainfiera.it/come-arrivare/](http://www.danzainfiera.it/come-arrivare/) page you will find information about getting a train ticket discount and a preferential coach tariff through the "R mark" which should be peremptorily requested within 5 (five) days before the event.

### **HOW TO TAKE PART**

#### **THE SCHOOL WILL:**

#### **1) REGISTER THE CHOREOGRAPHY AND PAY THE PARTICIPATION FEE (BY 20/01)**

To take part, you should register by 20 January 2023, by filling in the ONLINE FORM on the dedicated page of the website [www.danzainfiera.it](http://www.danzainfiera.it) attaching proof of payment of the relevant fee. At least one choreography per school will be accepted. PLEASE NOTE - the following should be included in the registration form:

- Any request for a second choreography which will be assessed by 20 February.
- Every requirement regarding the days and times on which you are available to perform.

The online form will be accompanied by a copy of the payment of the participation fee of 25 euros per dancer (for each choreography) to be paid by bank transfer to the Danza in Fiera srl account:

Reason for the payment: "Junior Parade + Name of School". The fee paid is nonrefundable. This amount does not include the Danzainfiera admission ticket.

## **2) REGISTER THE DANCERS ONLINE (BY 15/02)**

Once the fee has been credited, the reference person indicated will receive an email with the Username and Password for accessing the Events Portal <https://espositori.danzainfiera.it/login.php> and for registering all the dancers. This should be carried out by 15 February, indicating the FIRST NAME, LAST NAME and TAX CODE. After this date, unregistered dancers will not be allowed to perform and should buy a normal admission ticket directly at the fair in order to access the event.

*Effects of registration – The relationship between Danza in Fiera and the school*

*Registration for each participant, completed by the HEALTH DECLARATION form, shall entail acceptance of the regulations for Visitors and for this special Junior Parade show.*

*Danza in Fiera srl shall not manage the choreographic event organized by the school and its only relationship with the dancers registered shall concern their entrance to the fair.*

*The choreography with which the school requests to participate shall have the character of an event organized by the School on its own behalf to present its activities, without the payment of fees to the participants on behalf of the School and under its own responsibility with regard to the suitability of the dancers and the performance rights, concerning which Danza in Fiera srl shall remain extraneous; the School shall be obliged to hold the latter harmless from any demands made by the dancers and third parties.*

*Every aspect of the preparation and execution of the choreography shall be curated by the school with the Contact Person, barring the provision of the space and its services by Danza in Fiera srl and the formation of the order of the performances.*

*Participation in the performance shall not constitute the rental of the space used for the same and the presence at the fair and the carrying out of every activity shall remain subject to the general safety rules of the fair and the prescriptions of Danza in Fiera through its representatives.*

## **THE DANCER WILL**

### **1) REGISTER AND FILL IN THE HEALTH DECLARATION**

Each dancer registered for the show should, in turn, register on the Visitors' Portal <https://visitatori.danzainfiera.it/login.php> and fill in the HEALTH DECLARATION form.

This form should be completed by each participant (aged over eighteen) or, in the case of minors, by whoever exercises parental authority, and should be printed and signed in duplicate.

The HEALTH DECLARATION form should be displayed at the entrance to the Pavilion dedicated to the performance and throughout the time spent inside the same. The school cannot allow dancers who do not possess this documentation to take part in the choreographic event. The school shall be responsible for keeping the HEALTH DECLARATION forms for the fair in addition to the authorizations and certifications required by law for its activities and for those of its registered members.

## **2) PRINT THE EVENT VOUCHERS (FROM 20 TO 23/02)**

From 20 to 23 February, by accessing the Events Portal using the same credentials, it will be possible to download the EVENT VOUCHERS to be printed and shown at the fair, together with the special dancers' daily ticket at € 1 (+ € 0.50 advance booking fee). After this date it will no longer be possible to download the vouchers.

The vouchers are personal, non-transferable and a copy should be kept in order to avoid improper use or duplicates for which Dif shall not assume any responsibility; the system will only consider the first access to be valid, annulling any subsequent accesses.

## **3) PURCHASE THE ADMISSION TICKET (by 24/02)**

From the month of December, on the [www.danzainfiera.it](http://www.danzainfiera.it) website, the INFO, times and tickets section will contain a link to the online ticket office. Only people who have registered for the event can purchase the special dancers' daily ticket at € 1 (+ € 0.50 advance booking fee), valid for the day of the performance. This procedure is only valid for people in possession of an event voucher.

PLEASE NOTE - Dancers will be permitted to enter from 9.00 a.m.; they should present themselves at the fair (Fortezza da Basso – Porta Santa Maria Novella) at least 30 minutes before their own performance. The chance to perform will not be guaranteed in the event of late arrival.

All the performers should go to the entrance reserved for artists and dancers and show the daily ticket costing € 1 (+ € 0,50 advance booking fee) together with the event voucher.

## **THE DAY OF THE PERFORMANCE**

The day and time of the performance will be notified via email to the reference person in the days preceding the event.

### **DELIVERY OF MUSIC**

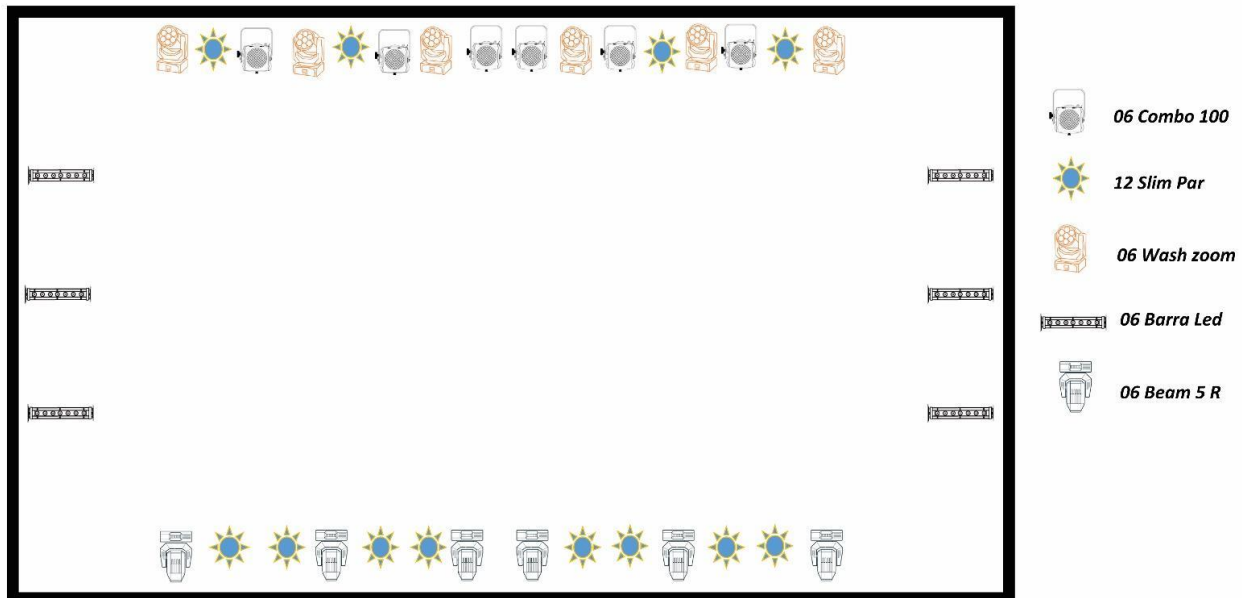
Once you arrive at the dedicated Pavilion for your performance, show the event voucher, the signed health declaration (mandatory in order to be able to perform) and give the stage manager the MUSIC – USB flash drive, MP3 or CD indicating the name of the school and the title of the choreography.

### **ACCESS TO THE DRESSING ROOMS**

The dressing rooms will be available for changing clothes only 30 (thirty) minutes before the performance. Please do not leave valuables unattended and take your bag away with you. Danza in fiera srl shall decline any responsibility for lost or misplaced objects.

## STAGE RULES

The performances will take place on a stage with a dancing area that has a 12 x 10 m dance floor, side wings, backdrop and backstage area. The relevant technical data sheet follows. Rehearsals will not be permitted, nor the use of scenery, dangerous set props (fire, water, liquid substances, talcum powder, confetti etc.), instruments that require amplification. Danza in fiera srl shall allow small, easily transportable objects which should be removed upon exiting the stage. Out of respect for all the performers, under no circumstances should the duration of the performance exceed the time allocated.

## ADMISSION OF PUBLIC

### TICKETS

On the [www.danzainfiera.it/orari-e-biglietti/](http://www.danzainfiera.it/orari-e-biglietti/) page you will find information about ticket costs and the conditions of purchase. For groups of at least 10 people, we suggest purchasing a reduced-price daily carnet; this option is only available online.

There will be a ticket office at the Fortezza.

### AUDIENCE RULES

Access to the public will be permitted according to the safety limits of the pavilion and, where necessary, the security personnel shall undertake to manage the flow of people in order to avoid overcrowding.

### PHOTOS

It shall be forbidden to film videos or take photos using any type of equipment. The event will be covered by official photographers who will guarantee this service; it will be possible to purchase the images on site and they can be viewed at the photographers' desk.
